MECHANICAL RESIDENTIAL APPLICATION

Permits are good for six (6) months from date of issue providing you have had an inspection once in a six (6) month period.

Chimneys must be three (3) feet above combustibles or two (2) feet above any obstruction ten (10) feet away and have a cleanout at base of chimney.

Switch for shut off must be installed adjacent to furnace.

LP Gas regulators MUST be placed three (3) feet from any opening and eighteen (18) inches below opening and eighteen (18) inches above grade.

All approved appliances must be installed according to manufacturer's specifications. Installation instructions must be on job when inspection is conducted.

Ventilation air must be through whole house.

Combustion air required in the area of the furnace.

All exhaust fans must be vented directly outside in metal pipe.

One appliance per flue if one is a solid fuel appliance.

Solid fuel appliances must be installed according to manufacturer's specifications or to State of Michigan Mechanical Code and MUST have a UL label or Label of recognized testing lab. Two inspections are required - Rough and Final.
